





# LOS ANGELES COUNTY COMMISSION ON HUMAN RELATIONS

#### Dispute Resolution Program

## PROGRAM DESCRIPTION

In 1986, the California Dispute **Resolution Programs** Act (DRPA) was signed into law. This law allows counties to fund alternative dispute resolution services from a portion of the filing fees collected for first papers in civil court actions. Currently, twelve agencies are contracted with DRPA funds to train and supervise mediators in Los Angeles County. These mediators' help people resolve their differences without the added cost of time and money required for full, formal court proceedings.

#### **SERVICES**

Mediation services are available for three types of disputes:

#### **Community**

Disputes for which there is time for conversation and collaboration, including merchant-customer, landlord-tenant, family, neighbor to neighbor, and debt disputes.

#### **Day-of-Hearing Court**

Disputes filed as civil actions in Los Angeles County that must be resolved on the day of hearing, including small claims, unlawful detainer, and civil harassment cases. These cases are identified at the courthouse on the day of the scheduled hearing.

#### **Victim-Offender**

Disputes that involve infractions or misdemeanors in which, using Restorative Justice principles and practices, persons accepting responsibility for harm-causing behavior and those harmed by the behavior are brought together for facilitated dialogue to share their experiences and plan the actions that will be used to repair the harm. These cases are referred by law enforcement or prosecuting agencies.

#### **ELIGIBILITY**

Any individual, business, or organization residing, working, or operating in Los Angeles County is eligible to receive DRPA-funded Mediation services at little or no cost.

#### **IMPACT**

During the 2015 - 16 fiscal year, DRPA-funded Contractors served over 20,000 LA County residents. That year they initiated 10,998 mediation cases and successfully assisted with resolving 78% of them.

#### **REQUESTING ASSISTANCE**

To request information about, or assistance with, Mediation services, call (213) 738-2621. Or you may call a Contract Provider agency directly. Below is a list of current Contract Provider agencies in Los Angeles County. Eleven include Community Mediation in the services they offer. Each agency that offers assistance with Community Mediation is contracted to provide services in one or more of 8 designated areas in the county.

Along with the name and phone number of each agency that offers Community Mediation services is an indication of area(s) for which that agency receives DRPA funds. The areas are described at the bottom of this page. Keep in mind that this information only describes services for which agencies receive DRPA funds. Agencies may also choose to offer services funded from other sources.
