MISSION

The mission of LACCOA is to advocate, advise, and make recommendations regarding the needs and welfare of Los Angeles County older adults 60 years of age and older to the Los Angeles County Board of Supervisors, departments of County government, and other entities that provide services to older adults regarding their needs, health, well-being, and rights.

To accomplish this mission, LACCOA:

- Assists Los Angeles County in preparing for expected growth within the older adult population.
- Networks and collaborates with other partners who are interested in and concerned regarding issues affecting older adults.
- Develops methods of communications which enhance and provide outreach and education to older adults in Los Angeles County.
- Advocates for the needs and well-being of older adults in Los Angeles County.

GOALS

- Advises the Board of Supervisors regarding needs of the older adult population in Los Angeles County.
- **Recognizes** outstanding voluntary efforts and community service by older adults living in Los Angeles County.
- **Enhances** the distribution of LACCOA information and findings to the community at large and to appropriate Los Angeles County Departments.
- **Maintains** efforts to assist the older adult population with information regarding transportation.

COMPOSITION

The Commission includes individuals and representatives of community organizations. The Commission shall be made up of:

- More than 50 percent of older adults, including minority older adults who are participants or who are eligible to participate in Area Agency on Aging (AAA) programs;
- Representatives of older adults;
- Representatives of health care provider organizations;
- Representatives of supportive services provider organizations;
- Persons with leadership experience in the private and voluntary sectors;
- Local elected officials; and
- The general public.





Ethnic distribution should be representative of the population served, and LACCOA members must be residents of Los Angeles County.

The Commission is comprised of 50 members: 25 appointed by the Board of Supervisors and 25 elected by LACCOA. Each vacancy will be filled accordingly.

The LACCOA General Meetings are held every first Monday of each month from 10:00 a.m. to 12:00 p.m. The Executive Board Meetings are held every third Monday of each month from 10:00 a.m. to 12:00 p.m. If there is a holiday on Monday, the meetings are held on Tuesday.

The Commission structure includes an Executive Board and six standing committees: Area Plan; Communications; Health, Nutrition, and Long-Term Care; Housing and Transportation; Legislative and Advocacy; and Membership.

LACCOA STRATEGIC PLAN UPDATE (JULY 2017 – JUNE 2018)



- **VISION:** Los Angeles County will be one of the best communities for older adults in the nation.
- **MISSION:** The mission of Los Angeles County Commission for Older Adults (LACCOA) shall be to advocate, advise, and make recommendations regarding the needs and welfare of Los Angeles County older adults 60 years of age and older, to the Los Angeles County Board of Supervisors, departments of County government, and other entities that provide services to older adults regarding their needs, health, well-being, and rights.

LACCOA developed the following Strategies and Objectives to guide its efforts in realizing its vision and mission in the period July 2016 – June 2020.

STRATEGY 1: Standing committees will continue to address immediate and long-term issues affecting the health, safety, and security of older adults in Los Angeles County and to facilitate the operation of LACCOA.

Objective 1:

By August of each year (2016-2020), standing committees will be formed, chairpersons selected, and goals developed for the coming year. Committees will meet monthly as necessary.

Objective 2:

Additional committees may be formed, as needed, to address immediate issues, pressing issues, or long-term needs.

STRATEGY 2: Advise Area Agency on Aging (AAA) staff on all matters relating to the needs and welfare of Los Angeles County older adults, including the planning process for Public Hearings on the Area Plan Updates each year (2016-2020).

Objective 1:

By July of each year (2016-2020), the Area Plan Committee will be formed to assist AAA staff at Public Hearings for input into the Area Plan Update.

Objective 2:

By January of each year (2017-2020), participate in Public Hearings for the Area Plan Update by encouraging attendance and community participation in the Public Hearings, attending and observing the hearings, and serving as Hearing Officers at the hearings as needed.

Objective 3:

Review the Area Plan Update each year (2017-2020).

STRATEGY 3: Advocate and increase awareness in the community regarding programs and services affecting older adults.

Objective 1:

The Speakers Bureau, composed of trained LACCOA Commissioners, will conduct presentations throughout Los Angeles County to increase the awareness of programs and services available to the older adult and disabled population.

Objective 2:

Develop a LACCOA video and make it available to the Speakers Bureau for use at their speaking engagements.

Objective 3:

Update the LACCOA Outreach Scorecard on a continuous basis, demonstrating the community activity of LACCOA members.

Objective 4:

The Speakers Bureau will participate in speaking engagements that will cover all five (5) Supervisorial Districts.

Objective 5:

Develop a flyer that provides information regarding the Speakers Bureau for distribution throughout Los Angeles County.

STRATEGY 4: Celebrate and acknowledge the contributions that older adults make in their respective communities.

Objective 1:

Work with the Board of Supervisors and Workforce Development, Aging and Community Services (WDACS) to host annual events to celebrate and acknowledge the contributions that older adults make in their communities.



During FY 2016-2017, LACCOA Commissioners visited over 30 senior and community centers throughout Los Angeles County, wrote letters of support, and traveled to the State Capitol to advocate on behalf of older adults in Los Angeles County.

In August 2016, commissioners served as moderators for the Vaccination Workshop presented by Workforce Development, Aging and Community Services (WDACS) staff. The workshop was presented to over 150 seniors at seven (7) senior centers: Montebello Senior Center, Potrero Heights, Triangle Square, Downey Community Senior Center, Antelope Valley Senior Center, Las Palmas Park, and East Rancho Dominguez Service Center. Commissioners also used their time visiting senior and community seniors to outreach and advocate by participating in town hall meetings, meeting with representatives from their local Supervisorial Districts, and the Board of Supervisors office.

In March 2017, LACCOA wrote a letter opposing the decision of Governor Jerry Brown to eliminate the Coordinated Care Initiative (CCI) and In-Home Supportive Services (IHSS) Maintenance of Effort (MOE). Eliminating these programs would mean that Los Angeles County will incur an additional cost of \$220 million for FY 2017-18. LACCOA believes these cuts from the state budget and moving the costs to Los Angeles County is an unjust action that will negatively impact the lives of older adults in Los Angeles County.

In March 2017, 200 elderly residents residing at 947 South Tiverton Avenue in Westwood, California were facing eviction as a result of the purchase of the property where they reside. In collaboration with WDACS staff, LACCOA drafted a letter expressing how the loss of housing would adversely affect the health and welfare of the older adult residents given the scarcity of suitable replacement housing available in Los Angeles County. The letter of support was sent to the Los Angeles County Board of Supervisors, the Director of City Planning for the City of Los Angeles, and Los Angeles City Attorney Mike Feuer.

On May 11, 2017, the Commission participated in Senior Rally Day in Sacramento, California. Senior Rally Day attracted over 500 seniors and advocates from around California. The aging community, advocates, and supporters converged at the State Capitol to urge the State Legislature to maintain adequate services and lobby for the rights of older adults in California.

Each year during the month of June, the California Association of Area Agencies on Aging (C4A) seeks to bring awareness to elder and dependent adult abuse by launching a month-long education and resource campaign. In June 2017, LACCOA sent letters to each Los Angeles County Senior Center Director requesting their support and participation in educating Californians regarding how to recognize different types of abuse and how to report abuse to the appropriate local Adult Protective Services (APS) agency.

In June 2017, LACCOA and its Commissioners wrote a letter to the Los Angeles County Board of Supervisors (BOS) urging them to amend their approval of the 2016 Homeless Initiative (HI). Of the 47 Strategies included in the HI to combat homelessness, none include age specific strategies for the near elderly or elderly population, which makes up 24% of Los Angeles County's homeless population. In order to determine the impact of the HI on Los Angeles County's elderly and near elderly homeless population, outcome data is necessary. Therefore, LACCOA requested that the HI include an age specific strategy to target individuals 55 years of age and older.
